



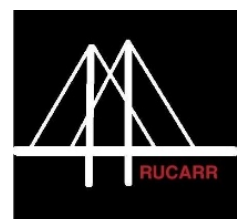

## The LUPSRUSS Project (September 2017 to February 2019)

The LUPSRUSS project, which is funded by the *Swedish International Centre for Local Democracy (ICLD)* seeks to examine the processes of urban planning in Scandinavia and Russia. Through paired comparison of different examples of urban planning, the project gives insight into the quality of governance and citizen involvement at the local level. The main focus is on the politics and processes behind sustainable planning and development in a number of comparable regions in each country, with particular emphasis on how to involve citizens in that process. A second aspect is on the incorporation of the needs of people with functional variation into the planning of cities. The LUPSRUSS project is also capacity-building, building on existing networks and fostering connections between scholars and municipalities in Sweden, Russia and Denmark.
